Reference is made to the bids opened on July 27, 2021, Bid Number 21-04 for the Headworks Modifications project.

Three Bids were received including \$10,000 owner's allowance – L7 Construction Inc – \$895,700, TLC Diversified Inc. – \$1,294,000, and Censtate Contractors, Inc. – \$976,900.

Attached for your review and approval is a copy of the tabulation of bids for all bidders. The apparent lowest and responsible bidder is L7 Construction Inc. at \$895,700. Kimley-Horn reviewed the Bid submitted, performed reference checks, and recommends that the City of Avon Park accept the bid and recommends award to L7 Construction Inc.
