### **1. Roll Call**

Meeting called to order by Co- Chairperson Judie Lehman

Also Present: City Attorney Glinda Pruitt, City Clerk Bonnie Barwick, and Director of Administrative Services Bea Ramirez, Mayor Garrett Anderson, and Superintendent of Public Works Jimmy Runner, Director of Avon Park Chamber, George Karos, and Chairperson of Main Street CRA Advisory Board Gaylin Thomas. Members of the audience.

Invocation was given and the Pledge of Allegiance was recited.

- 2. Approval of minutes from the May 15, 2017 Regular Meeting: Motion** by Anna Marie Feeney, Seconded by Alice Oldham to approve minutes of May 15, 2017 meeting as presented. Motion passed unanimously.
- 3. Mayor Anderson** answered questions regarding who the committee answered to. Mayor Anderson stated that they answered only to the Council not the CRA Advisory Board. Main Street CRA Advisory Board Chairperson Gaylin Thomas asked if the CRA Advisory Board had anything to do with the Committee. Mayor Anderson stated that they did not. He went on to explain the only time they would have to go to the CRA Advisory Board was if the Committee wanted to use CRA Funds, or if they wanted to partner with the CRA Board. Mayor Anderson stated his idea was for the Committee to come up with a plan for the mall and bring it back to the Council for action. It was brought to the attention of the Committee, that a few years back a plan had been done by an individual firm. **Motion** made by Anna Marie Feeney, Seconded by Alice Oldham to have the plan available for the committee before the next meeting. After further discussion motion passed unanimously. Mayor Anderson said he felt that the foliage would be done first.  
It was suggested that the new Parking Lot be dedicated to the "First Responders",  
It was suggested that everyone share ideas and website links for Avon Park. The Co Chairperson was asked to make sure the City Clerk gets the Agenda in time to post it before the meetings.

There was discussion regarding whether a person or an organization could adopt a portion of the Mall. It was suggested that we copy the plan from Lake Placid. Gaylin Thomas stated that DeeDec Harstine had received the plan from Lake Placid, and she would have it for the next meeting.

**Motion** made by Rosie Longenecker , Seconded by Alice Oldham to have the agenda for the meetings put on the City Web Site. Motion passed unanimously.
